DETAILED ACTION

Allowable Subject Matter

- 1. Claims 1-30 are allowed.
- 2. The following is an examiner's statement of reasons for allowance:

Regarding independent claims 1 and 20, the cited reference, Sporre, teaching a method and system to perform signal strength measurements on non-BCCH carrier frequencies by including an identification of those frequencies (see abstract), which fail to teach "without incuding any identification parameters of the cells" for the purpose of report cells without increasing the length of the reporting message or reducing the number of the cells reported by a single message (Application specification 1st paragraph page 7).
