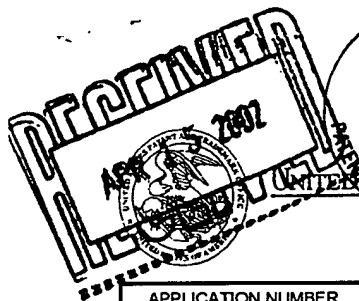

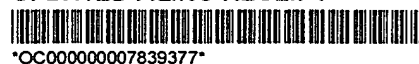

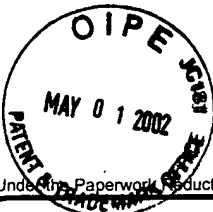
In response to your request for a corrected Filing Receipt, the Office is unable to comply with the request because:
