Reasons for allowance

1. This communication is in response to applicant's 11/14/2005 Amendment after the Final in the application of Hasty, Jr. et al. for a "System and method for using per-packet receive signal strength indication and transmit power levels to compute path loss for a link for use in layer II routing in a wireless communication network" filed 03/06/2002. The amendment and response has been entered and made of record. Claims 7, 18, 29 has been canceled per Applicant's request, and Claims 1, 12, 23 have been amended. The claims have been amended to better point out and more distinctly claim subject matter comprising the invention.

2. Claims 1-6, 8-17, 19-28, 30-51 are allowable as evident by applicant's amendment (Claims are renumbered as 1-48 respectively)

3. The following is an examiner's statement of reasons for allowance: The closest prior art of record fails to disclose or suggest the specific equation for calculating the link quality ratio as expressly recited in the claims. The instant invention, in combination with the other claimed features, improves upon the Prior Art by providing a method and system for using indications of per-packet receive signal strengths and per-packet transmit power levels to compute path losses for links between nodes in a communication network, such as an 802.11 network, in order to select the most suitable link over which to send data packets between the nodes.
