Regarding claims 1-8

The inventions described in claims 1-8 do not appear to be novel or to involve an inventive step based on documents 1-3 cited in the ISR.

Documents 1-3 describe *Fucophilus fucoidanolyticus* derived end- α -fucosidase and degrading Fucoidan using said enzyme.

The inventions described in claims 4 and 6-7 do not appear to be novel or to involve an inventive step based on documents 4-5 cited in the ISR.

Documents 4-5 describe determining structures for *Fucus vesiculosus* and *Ascophyllum nodosum* derived Fucoidan.

Regarding claims 1-9

The invention described in claim 9 does not appear to involve an inventive step based on documents 1-3 cited in the ISR.

Using *Fucus vesiculosus* or *Ascophyllum nodosum* derived Fucoidan as a matrix for end- α -fucosidase is something that a party skilled in the art can easily do.
