DETAILED ACTION

Election/Restrictions

1. Restriction to one of the following inventions is required under 35 U.S.C. 121:
 - I. Claims 14-20, drawn to transporting a memory device between a storing location and a docking location, classified in class 710, subclass 304.
 - II. Claims 21-26, drawn to a switching controller to switch on and off a first and a second switches, classified in class 713, subclass 300.

2. The inventions are distinct¹, each from the other because of the following reasons:

Inventions II and I are unrelated. Inventions are unrelated if it can be shown that they are not disclosed as capable of use together and they have different designs, modes of operation, and effects (MPEP § 802.01 and § 806.06). In the instant case, the different inventions have different designs, and modes of operation.


