Applicants respectfully note that there have been overpayments totaling \$1,508.00 in fees with respect to the above-referenced U.S. patent application and therefore request a refund of **\$1,508.00**.

On September 3, 2004, Applicants filed U.S. Patent Application Serial No. 10/506,524 (now U.S. Patent Publication No. 2005-0147617) along with Form PTO-1390. On page 2 of Form PTO-1390, Applicants authorized the U.S. Patent and Trademark Office to charge \$1,856.00 to Applicants' Deposit Account No. 50-0426 to cover the patent application filing fee (\$1,080.00 represented the Basic National Filing Fee; \$290.00 represented the multiple dependent claims fee; and \$486.00 represented the extra claims fee for a large entity). On September 9, 2004, Applicants' Deposit Account No. 50-0426

Serial No.: 10/506,524

was charged the \$1,856.00. A copy of the Deposit Account Statement reflecting the charge to the deposit account is attached hereto as Exhibit A.

On September 30, 2004, Applicants filed a REQUEST FOR CHANGE FROM LARGE ENTITY STATUS TO SMALL ENTITY STATUS AND REQUEST FOR REFUND along with a return-receipt postcard. Applicants requested a refund in the amount of \$928.00, which represented the difference between the patent application fees for a small entity and a large entity. Applicants thereafter received the return-receipt postcard that was division- and date-stamped by the U.S. Patent and Trademark Office indicating the request was received. Copies of the REQUEST FOR CHANGE FROM LARGE ENTITY STATUS TO SMALL ENTITY STATUS AND REQUEST FOR REFUND and stamped return-receipt postcard are attached hereto as Exhibit B.

On November 29, 2004, Applicants received a letter from the U.S. Patent and Trademark Office that acknowledged receipt of the refund request for this application in the amount of \$928.00. A copy of the letter from the U.S. Patent and Trademark Office, dated November 12, 2004 and received on November 29, 2004, is attached hereto as Exhibit C. No further action was taken by the U.S. Patent and Trademark Office pursuant to Applicants' REQUEST FOR CHANGE FROM LARGE ENTITY STATUS TO SMALL ENTITY STATUS AND REQUEST FOR REFUND. Therefore, Applicants were never credited said amount. Applicants hereby request a refund to Deposit Account No. **50-0426** in the amount of **\$928.00**.

On January 7, 2005, Applicants received a Notification of Missing Requirements under 35 U.S.C. § 371 in the United States Designated/Elected Office (DO/EO/US) that charged Applicants \$130.00, representing the late oath or declaration surcharge for a large entity. On March 3, 2005, Applicants responded by reasserting small entity status and by

paying \$65.00, representing the late oath or declaration surcharge for a small entity. On March 9, 2005, Applicants were charged \$65.00 to Deposit Account No. 50-0426, verifying its status as a small entity by the U.S. Patent and Trademark Office. Copies Applicants' Response and of the Deposit Account Statement reflecting the charge to the deposit account are attached hereto as Exhibit D.

On May 31, 2007, Applicants filed a Response to Restriction/Election Requirement along with check number 27606 for \$1,080.00, representing the five (5)-month extension of time fee for a small entity. Copies of the front and back check of number 27606, duly endorsed by the Patent and Trademark Office, are attached hereto as Exhibit E.

On December 6, 2007, Applicants filed an Amendment A and an Information Disclosure Statement along with a check in the amount of \$300.00 (\$180.00 represented the Information Disclosure Statement fee and \$120.00 represented the one (1)-month extension of time fee for other than small entity). As the Information Disclosure Statement fee is not subject to entity size, Applicants' fee for such filing should remain the same. However, Applicants should have paid \$65.00 for the one (1)-month extension of time fee for a small entity instead of the large entity fee; therefore, Applicants hereby request a refund in the amount of **\$55.00**. A copy of the front and back of check number 29220 in the amount of \$300.00, and duly endorsed by the Patent and Trademark Office, is attached hereto as Exhibit F.

On September 25, 2008, Applicants filed an Amendment C, which included authorization for the United States Patent and Trademark Office to charge \$1,050.00 to Deposit Account No. 50-0426 to cover the three (3)-month extension of time fee for other than a small entity. However, Applicants should have been charged \$525.00, which was the three (3)-month extension of time fee for a small entity; therefore, Applicants hereby


request a refund in the amount of **\$525.00**. A copy of the Deposit Account Statement reflecting the charge to the deposit account is attached hereto as Exhibit G.

Applicants hereby request a total refund of **\$1,508.00** (\$928.00 representing the difference for the patent application filing fee; \$55.00 representing the difference for the one (1)-month extension of time fee; and \$525.00 representing the difference for the three (3)-month extension of time fee for a small entity instead of a large entity). Since the charges to Deposit Account No. 50-0426 were erroneous, as well as unnecessary to cover the cost of the fees, Applicants respectfully request that the \$1,508.00 in fees be refunded to Deposit Account No. 50-0426.

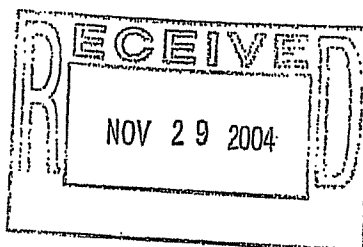


