

Hence, applicants respectfully request that the Patent Office correct this error and request that a Corrected Filing Receipt be issued.



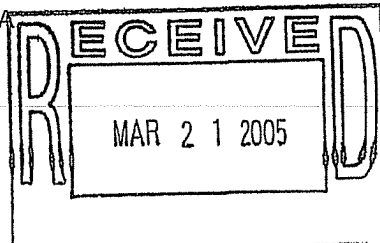
