Allowable Subject Matter

1. Claims 1-3 are presently allowed.
2. The following is an examiner's statement of reasons for allowance:

The cited art of record fails to teach a ballast device for a discharge lamp comprising a series capacitor through which a DC voltage of said DC voltage supply stage is supplied to the starting transformer, and a ballast inductance connected to an electrode of the discharge lamp which is ; not connected to the starting transformer, there is a first connecting point between the series capacitor and the starting transformer, there is a second collecting point between the discharge lamp and the ballast inductance a capacitor is connected in series with a switch between the first and second connecting points said capacitor forms, a series resonant circuit with the ballast inductance. and said series resonant circuit ' is tuned to a higher harmonic of the clock frequency with a combination of all recitations as defined in claim 1.
