## **DETAILED ACTION**

### **Response to Arguments**

1. Applicant's arguments, see pages 7-9 of the Remarks, filed 03/09/2010, with respect to claims 1-26 have been fully considered and are persuasive. The rejection of claims 1-26 has been withdrawn.

## Allowable Subject Matter

2. The following is an examiner's statement of reasons for allowance: The cited prior art of record considered as a whole (either alone or in combination) fails to teach or suggest:

A method of manufacturing an optical recording medium and an optical recording medium comprising: at least a reflective layer, a lower dielectrics layer, a recording layer, an upper dielectrics layer and a light transmissive layer that are sequentially laminated on one main surface of a substrate, wherein, light having a wavelength in the range of 400 nm or more and 410 nm or less is focused with an optical system having a numeral aperture In the range of 0.84 or more and 0.86 or less followed by irradiating from a side of the light transmissive layer on the recording layer, and thereby an information signal is recorded and reproduced, the lower dielectrics layer includes a first lower dielectrics layer (i) spacing the reflective layer from the first lower dielectrics layer and (ii) formed of a material that inhibits corrosion of the reflective layer; and the upper dielectrics layer includes a first upper dielectrics layer and a second upper dielectrics layer laminated onto the first upper dielectrics layer, the second upper dielectrics layer laminated onto the first upper dielectrics layer and a second upper dielectrics layer laminated onto the first upper dielectrics layer and a second upper dielectrics layer laminated onto the first upper dielectrics layer and a second upper dielectrics layer laminated onto the first upper dielectrics layer and a second upper dielectrics layer laminated onto the first upper dielectrics layer.
