DETAILED ACTION

Response to Amendment

Applicant's amendments to the claims and specification, filed 4/4/2007, are accepted and appreciated by the examiner. In response all previous grounds for rejection and objection are withdrawn.

Allowable Subject Matter

Claims 1-3, 5-18 are allowed. Applicant has amended the claim language to sufficiently distinguish the claimed invention from the prior art of record. Specifically, the use of a random initial estimate modified by angular position sensors to determine a final orientation is non-obvious. Prior art now made of record, Beveventano (US pat 4686771) discloses an algorithm for iteratively modifying an estimated orientation based upon angular position sensors. Beveventano further discloses sensors sensitive to gravity. However, one of ordinary skill in the art would not have found it obvious to modify or otherwise combine either Beveventano or Griffis to arrive at the claimed invention.
