REASONS FOR ALLOWANCE

The following is an examiner's statement of reasons for allowance:

Applicants' response, which included cancellation of claims 12, 13, 32, 33 and 41-46, filed on 12/05/2006, is made of record. Claims 1-9, 11, 14, 20, 25-31 and 34-40 are now pending.

In view of applicants' response, particularly cancellation of claims 12, 13, 32, 33 and 41-46, the 112 second and first paragraph rejections of these claims made in the previous office action has been rendered moot.

The compounds of formula I & IA, their composition and method of uses as embraced in claims 1-9, 11, 14, 20, 25-31 and 34-40 were not found to be anticipated or rendered obvious by the prior art of record. Additional search in the related art area also did not yield any prior art teaching or suggesting the compound of formula I & IA, their composition and method of uses embraced in the instant claims. Therefore, the examiner noted that the claims 1-9, 11, 14, 20, 25-31 and 34-40 would be in condition for allowance.
