DETAILED ACTION

1. Applicant's response filed on 11/12/2008 is acknowledged. Claims 1-4 and 7 are canceled by applicant.

Allowable Subject Matter

2. Claims 5-6 are allowed.

The following is a statement of reasons for the indication of allowable subject matter:

The prior art of record fail to teach or suggest an image pickup device with a packaging having a cover with a guiding opening for inserting at least a part of a fiber optic plate into the packaging cavity as outlined in combination of other elements of claims 5 or 6.
