An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicant, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it MUST be submitted no later than the payment of the issue fee.

Authorization for this examiner's amendment was given in a telephone interview with Paul Davis on 25 February 2009. Applicant agreed to amend claims 1, 2, and 12 for purposes of clarity. Claims 11, 15, and 19, were determined to be somewhat redundant or not necessary, in view of Applicant's amendments to claim 1, and therefore will be cancelled. A corrected version of claim 21 is presented to provide a proper version of the claim on the record.

The application has been amended as follows:

Claim 1 was amended as follows:

1. A body fluid sampling device comprising:

a cartridge containing a plurality of penetrating members;

a drive force generator coupled to a processor and configured to be coupled to an active one of said penetrating members and to move said active one of said penetrating members;

[a penetrating member coupled to the drive force generator,] the processor configured to provide information relative to a depth of penetration of [a] said active one of said penetrating members through a skin surface when said active one of said penetrating members is moved; and

a plurality of analyte detecting members each associated with [a] one of said penetrating members, the plurality of analyte detecting members being attached to a bottom surface of said cartridge, wherein a first portion of the analyte detecting members measure a first analyte and a second portion of the analyte detecting members measure a second analyte.

Claim 2 was amended as follows:

2. The device of claim 1 wherein the penetrating member driver is coupled to a position sensor in communication with the processor, said position sensor used to detect a position of the active one of said penetrating members while penetrating tissue.

Claim 11 was cancelled.

Claim 12 was amended as follows:

12. The device of claim 1 wherein [all tests are run,] the processor is configured to measure the first and the second analyte while reporting only those [tests,] results which are desired at the time the sample is taken [need to be reported].

Claim 15 was cancelled.

Claim 19 was cancelled.

The amended version of claim 21 presented in the amendment filed 15 December 2008 inadvertently rearranged the order of several of the claim terms. A corrected version showing the previously presented amendment, but with no additional amendments, is given below to correctly set forth claim 21:

21. A method of body fluid sampling comprising:

moving a penetrating member [at] conforming to a selectable velocity profile or motion waveform;

piercing a storage area having a sensing area;

piercing another storage area having an enzyme area separate from the sensing area prior to piercing;

causing fluid to first flow to the enzyme area and then to the sensing area.
