2. Citations and explanations:

Claims 1-17 lack novelty under PCT Article 33(2) as being anticipated by CHIRON CORPORATION (WO 2004/041157 A2).
CHIRON CORPORATION taught a composition comprising a combination of GBS 80 antigen having the amino acid sequence of SEQ ID NO: 2 or a fragment thereof, and GBS 322 antigen or a GBS saccharide antigen. The antigen combination in the composition can consist of 2-5 GBS antigens and includes GBS 80, GBS 104, GBS 276, GBS 91, GBS 184 etc.
