DETAILED ACTION

Allowable Subject Matter

Claims 19-34 are allowed.

The following is a statement of reasons for the indication of allowable subject matter: The prior art of record fails to teach authenticating a caller who attempts to directly access a called party's multimedia (or unified) mailbox to deposit a multimedia message, wherein authenticating is by accessing a store (database) associated with the called party to determine if the caller is a party who has previously received a communication from the called party.

The closest prior art of Paxson (US 6,327,344) teaches enable a caller to directly access a called party's voice mailbox to deposit a voice message. Paxson teaches that the caller uses an access code to enter the voice mailbox. Paxson fails to teach determining, from a database or a called party's profile, if the caller is a party who has previously received a communication from the called party in order to allow the caller to directly access the voice mailbox.

Conclusion

The prior art made of record and not relied upon is considered pertinent to applicant's disclosure of direct mailbox access.
