The claimed invention

The claimed invention relates to concealing, to involved parties, monitoring of media flow when the flow is monitored via an extra port in a media-handling node.

The cited documents represent the general state of the art. The invention defined in claims 1-7 is not disclosed by any of these documents.

The cited prior art does not give any indication that would lead a person skilled in the art to the claimed method and arrangement for concealing, to involved parties, monitoring of media flow when the flow is monitored via an extra port in a media-handling node. Therefore, the claimed invention is not obvious to a person skilled in the art.

Accordingly, the invention defined in claims 1-7 is novel and is considered to involve an inventive step. The invention is industrially applicable.
