The International Bureau will send a copy of such comments to all designated Offices unless an international preliminary examination report has been or is to be established. These comments would also be made available to the public but not before the expiration of 30 months from the priority date.

In respect of other designated Offices, the time limit of **30 months** (or later) will apply even if no demand is filed within 19 months.
