DETAILED ACTION

Election/Restrictions

1. Restriction is required under 35 U.S.C. 121 and 372.

This application contains the following inventions or groups of inventions which are not so linked as to form a single general inventive concept under PCT Rule 13.1.

Group I, claim(s) 1-15, 32-34 are drawn to a transmitter of a conditional access system.

Group III, claim(s) 27-30, 31 are drawn to a mobile transceiver of a conditional access system.

The inventions listed as Groups I, II, and III do not relate to a single general inventive concept under PCT Rule 13.1 because, under PCT Rule 13.2, they lack the same or corresponding special technical features for the following reasons: the control message with information relating to a transmission time for control messages that are to be transmitted in the future, is not novel and has been found in prior art.
