(54) Title: **YOGHURT FORMULATION COSMETIC COMPOSITION**

(57) Abstract: The present invention relates to a cosmetic composition with appearance and texture of curd yoghurt realized by containing xanthan gum and mannan. In addition, the present invention can provide skin moisturizing and softening effects improved by further containing vegetable or fruit, or vitamins or yoghurt powder.
