The examiner has considered applicant's argument however it is the official stance of the examiner that applicant's arguments in no way place the application in a condition for allowance. Applicant presumes "there are no similarities between a file system and the claimed interface component" as middle-ware is not a file system section (FSS). Firstly in response to applicant's argument that Rajaram's method for field diagnosing and updating system software in a wireless device is not directed to testing a mobile terminal. The examiner respectfully disagrees, field diagnosing is a type of testing as it checks the operating conditions of the mobile terminal, albeit 'in the field.' While true that Rajaram has a storage component comprised in his FSS, it is pointed out by the examiner that what the prior art teaches in addition to things applicant has not claimed is by no means a grounds for traversal. Simply put, Rajaram's teachings of applicants claims with additional teachings still reads on applicant's claims.
