A series of applications by Arthur Krieg, et al. copied claims from the above-identified applications, with respect to which Krieg, et al. alleges that there is overlapping subject matter and has requested that interferences be declared. See U.S. Patent Application Nos. 10/690,495; 11/296,644; 11/296,572; and 11/507,079.
