

Continuation of 3. NOTE: Entry of proposed/new claim 89 requires further search and consideration.

Continuation of 11. does NOT place the application in condition for allowance because: The rejection of claims based on Iwasaki et al. (U.S. 5,240,966) has not been withdrawn. The present claims are drawn to a plasticized polyolefin composition comprising polyolefin and plasticizer. Neither the term "plasticized \*melt\* blend" nor the extent of plasticization is indicated in the claim language. Therefore, the composition of Iwasaki et al., which contains polyolefin that has been blended with plasticizer, is considered "plasticized." It is the examiner's position that the subject matter of the claims remains anticipated over the prior art, and consequently, the rejection has not been withdrawn..
