### REASONS FOR ALLOWANCE

The following is an examiner's statement of reasons for allowance:

Applicant has claimed uniquely distinct features in the instant invention which are not found in the prior art, either singularly or in combination. According to the invention, a communications device is disclosed. The communications device includes a logging module. The logging module is configured to communicate information regarding a change to a configuration of a subsystem of the communications device.

Further, the invention also comprises a method for securing a communications device using a logging module is disclosed. The method includes detecting a change in a configuration of a subsystem of a communications device, and communicating information regarding the change.

These features are not found or suggested in the prior art.


