***Allowable Subject Matter***

Applicant's arguments filed 9/19/2005 with respect to the amended claimed 12 have been fully considered and found persuasive. Claims 12-31 are allowed.

The following is an examiner's statement of reasons for allowance:

Claim 12 recites a communication semiconductor integrated circuit device comprises a transmission unit is formed on a semiconductor chip, a reception unit is formed on the semiconductor chip, a protection unit is formed on the chip and coupled to the low noise amplifier transistor, wherein the protection unit includes a first protection circuit is coupled between a first voltage line and the terminal, a second protection circuit is coupled between a second voltage line and the terminal, the first and second protection circuits are directly coupled in common to the terminal. The references of record do not teach or suggest the aforementioned limitation, nor would it be obvious to modify those references to include such limitation.


