

SUPPLEMENTAL INTERVIEW SUMMARY

The following is a supplemental interview summary to that provided to the patent office in the response dated December 13, 2005.

Applicants previously filed an interview summary on December 13, 2005. However, the interview summary in accordance with 37 C.F.R. § 1.133, the following is a summary of an in-person interview conducted with Examiner DeJong and the Applicants on May 24, 2005 at the U.S. Patent and Trademark Office between Joyce Morrison, Kenton Abel, Ardin Marschel, John Dejarlais, and Examiner DeJong. During the interview, the arguments presented in the Amendment filed on April 4, 2005 by the Applicant (and now of record in this application) were discussed, as well as the Examiner's claim rejections under 35 U.S.C. §§ 101 and 112 from the previous Office Action, mailed January 4, 2005. Agreement was not reached.

The Examiner and Applicants incorrectly identified one of the parties. John Desjarlais, not Basil Dahiyat as stated by Applicants in the December 13, 2005 interview summary, was present at the interview. The Examiner incorrectly identified John Desjarlais as "John Dahiyat."
