

1. This action is responsive to communication filed August 16, 2007. Claims 1, 2-12 and 14-22 are now allowed. Claims 2 and 13 have been canceled.

REASONS FOR ALLOWANCE

2. The following is an Examiner's Statement of Reasons for Allowance:

The prior arts of record do not teach nor suggest, *either alone or in combination*, **all** the limitations of the amended claims of the current invention (claims 1 and 12). The discussion of the reasons for allowance shall be directed to claim 1 in which the Examiner shall designate as the primary invention in this application; however, the reasons for allowance will also apply to other indicated independent claim (claim 12).

Particularly, the prior arts of record do not teach nor suggest all the combined limitations in each claim separately including a method for transferring data in parallel from an external memory device to an integrated circuit comprises transferring a start read address from the integrated circuit via data lines to the external memory device; providing a clock signal generated by the integrated circuit to the external memory device; sequentially generating read addresses in response to the clock signal beginning with the start read address using an address counter in the external memory device; reading data stored in the external memory device at the read addresses; transferring the data in parallel from the external memory device to the integrated circuit; resetting a read address to the start read address when an output enable signal generated by the integrated circuit has a first voltage, wherein the address counter increments the read address in response to the clock signal when the output enable signal has a second voltage; similarly for other independent claim 12. In light of the foregoing, claims 1 and 12 of the present application are found to be patentable over the prior arts.

Claims 3-6 and 14-22 further limit the allowable independent claims 1 and 12. These claims are therefore allowable for the same reason as set forth above.


