### **DETAILED ACTION**

Claims 1, 4-7, 10-12, 15-18 and 21-23 are pending.

Claims 2, 3, 8, 9, 13, 14, 19 and 20 have been cancelled by the Applicant.

Claims 1, 4-7, 10-12, 15-18, and 21-23 are allowed.

### ***Reason for Allowance***

1. The following is an examiner's statement of reasons for allowance:

The prior arts of record do not teach the following:

In regards to claims 1, 7, 12 and 18 the prior arts do not teach the steps of determining whether the arrival times of frames are in accordance with a second temporal offset and a second temporal period, and steps of establishing when arrival times are in accordance with second temporal offset and second temporal period, a transmission schedule for transmitting each of frames to sender of polling request wherein transmission schedule is based on second temporal offset and second temporal period.

The prior arts alone or in combination fail to jointly suggest or teach the claimed combination of features as taught by the instant application. Therefore claims 1, 4-7, 10-12, 15-18, and 21-23 are to be deemed allowable over prior art.


