1. The Examiner acknowledges that claims 1-14 were cancelled in the paper of 10/1/03. The Examiner notes that Applicant should provide a copy of the claims with the proper claim status modifiers.

2. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless -

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

3. Claims 15-24 are rejected under 35 U.S.C. 102(b) as being anticipated by Wentfort, Jr. et al.

Wentfort, Jr. et al. discloses a wire drawing die comprising :

an first part comprising a first material (11); and

a second part comprising a second material (13);

wherein said first a second materials are in direct contact; and wherein said second material comprises steel.

4. Claims 15-24 are rejected under 35 U.S.C. 102(b) as being anticipated by Engelfriet et al.

Engelfriet et al. discloses a wire drawing die comprising :

an first part comprising a first material (5); and

a second part comprising a second material (6);

wherein said first a second materials are in direct contact; and wherein said second material comprises steel.

5. The nonstatutory double patenting rejection is based on a judicially created doctrine grounded in public policy (a policy reflected in the statute) so as to prevent the unjustified or improper timewise extension of the "right to exclude" granted by a patent and to prevent possible harassment by multiple assignees. See *In re Goodman*, 11 F.3d 1046, 29 USPQ2d 2010 (Fed. Cir. 1993); *In re Longi*, 759 F.2d 887, 225 USPQ 645 (Fed. Cir. 1985); *In re Van Ornum*, 686 F.2d 937, 214 USPQ 761 (CCPA 1982); *In re Vogel*, 422 F.2d 438, 164 USPQ 619 (CCPA 1970); and *In re Thorington*, 418 F.2d 528, 163 USPQ 644 (CCPA 1969).

A timely filed terminal disclaimer in compliance with 37 CFR 1.321(c) may be used to overcome an actual or provisional rejection based on a nonstatutory double patenting ground provided the conflicting application or patent is shown to be commonly owned with this application. See 37 CFR 1.130(b).

Effective January 1, 1994, a registered attorney or agent of record may sign a terminal disclaimer. A terminal disclaimer signed by the assignee must fully comply with 37 CFR 3.73(b).

6. Claims 15-24 are rejected under the judicially created doctrine of obviousness-type double patenting as being unpatentable over claims 11-26 of U.S. Patent No. 6,461,563. Although the conflicting claims are not identical, they are not patentably distinct from each other because the pending claims are encompassed by the claims of the conflicting patent.
