EXAMINER'S AMENDMENT

The application has been amended as follows: Claims 27-31 have been canceled;

Allowable Subject Matter

2. Claims 1, 4, 8, 17-20, and 22-24 are allowed.

3. The following is an examiner's statement of reasons for allowance: no prior art has been found to teach, disclose, or fairly suggest a multilayer film for roofing membranes, comprising a second barrier layer made of lacquer; in combination with all of the other limitations of claim 1, 22, 23, and 24. The examiner is relying on Applicants' argument on page 13, 4th paragraph, as the basis for allowance.

4. The claims are also allowed due to the Terminal Disclaimer timely filed on 5/16/2007.
