DETAILED ACTION

Amendment

1. The Amendment filed 08/26/2004 has been entered. The present Office Action is made with all the arguments being fully considered.

Independent claims 1, 11 and 22 have been amended.

Claims 1-22 remain pending in this office action.

ALLOWANCE

2. Claims 1-22 are allowed.

Reasons for Allowance

3. The following is an examiner's statement of reasons for allowance:

A UV lamp system comprising a radiator and an RF screen that is releasably attached to the radiator by a snap-fit connector having a portion attached to the RF screen and a complementary portion of the snap-fit connector to the radiator, as recited in claim 1, is neither anticipated nor rendered obvious by any prior art.

Claim 22 is allowed for reciting a reflector as part of the UV lamp system similar to claim 1, wherein a portion of the snap-fit connector is attached to the RF screen and a complementary portion of the snap-fit connector to the reflector.

Claim 11 is allowed for reciting a reflector having a pair of flanges as part of the UV lamp system similar to claim 1, wherein a portion of the snap-fit connector is

attached to the RF screen and a complementary portion of the snap-fit connector to the reflector flanges.

Claim 21 is allowed for reciting a reflector having a pair of flanges as part of the UV lamp system similar to claim 1, wherein the snap-fit connector comprises spring latch attached to one of the reflector flanges and the complementary portion of the snap-fit connector is a ball stud attached to the RF screen releasably engageable with the spring latch in order to releasably attach the RF screen to the reflector, the ball stud being disposed through a gasket laid between the RF screen frame and the pair of reflector flanges.

Claims 2-20 and 12-20 are also allowed because of their dependencies, either directly or indirectly, upon the allowed claims 1 or 11.
