## **DETAILED ACTION**

### ***Remarks***

1. Claims 1 and 3-8 are pending in this office action. Claim 2 has been cancelled.

### ***Allowable Subject Matter***

2. Claims 1 and 3-8 are allowed.
3. The following is an examiner's statement of reasons for allowance: the closest prior art, Reynier et al. (US 3,960,599) and Nishijima et al. (US Pub. Pat. App. No. 2004/0043288)., do not teach or fairly suggest a bipolar battery wherein a sealing layer is made of a second resin sandwiched by a first resin, positioned between current collectors, and the second resin has a higher melting point than the first resin, and the current collectors are thermally welded at a temperature between the melting points of the first and second resins.
