Continuation of 3. NOTE: The limitation, "wherein the phenolic antioxidant is in a purified tannin fraction of plant origin" has not been previously claimed. At this point in the prosecution it is unclear as to whether use of a phenolic antioxidant of a purified tannin fraction of plant origin would have been obvious; furthermore a new search would be required for art relevant to addressing this new issue.
