- 455. (New) The adhesive of claim 18, wherein the polymer has a percent crystallinity of 10-30 %.
- 456. (New) The adhesive of claim 18, wherein the polymer has tensile strength at break of 0.75 MPa or more.
- 457. (New) The adhesive of claim 18, wherein the polymer has a SAFT of 100-130°C.
- 458. (New) The adhesive of claim 18, wherein the polymer has a Shore A hardness of 20-90.
- 459. (New) The adhesive of claim 18, wherein the polymer has a Dot T-Peel of between 3 and 10,000 N.
- 460. (New) The adhesive of claim 18, wherein the polymer has a Dot T-Peel of between 10 and 2,000 N.
- 461. (New) The adhesive of claim 18, wherein the polymer has a tensile strength at break of 0.6 MPa or more.
- 462. (New) The adhesive of claim 18, wherein the polymer comprises at least 50 weight % propylene.
- 463. (New) The adhesive of claim 18, wherein the polymer comprises at least 50 weight % propylene and up to 50 weight % of a comonomer selected from the group consisting of ethylene, butene, hexene, octene, decene, dodecene, pentene, heptene, nonene, 4-methyl-pentene-1, 3-methyl pentene-1, 3,5,5-trimethyl-hexene-1, and 5-ethyl-1-nonene.

- 481. (New) A packaging adhesive comprising the adhesive of claim 18.

- 497. (New) The hot melt adhesive composition of claim 487, wherein the adhesive composition has a tensile strength at break of 55 bar or more at 25°C.
- 498. (New) The hot melt adhesive composition of claim 487, wherein the adhesive composition has a percent elongation of 200% or more strain of the original length at 25°C.

501. (New) A glue stick comprising an elongated member that includes the adhesive composition of claim 18.

- 605. (New) The glue stick of claim 598, wherein the adhesive composition comprises 1 percent by weight or less of the one or more antimicrobial agents.
- 606. (New) The glue stick of claim 598, wherein the adhesive composition has a percent substrate fiber tear of from 75% to 100% at 25°C.
- 607. (New) The glue stick of claim 598, wherein the adhesive composition has a percent substrate fiber tear of from 95% to 100% at 25°C.
- 608. (New) The glue stick of claim 598, wherein the adhesive composition has a PAFT of 60°C or more.
- 609. (New) The glue stick of claim 598, wherein the adhesive composition has a SAFT of 70°C or more.
- 610. (New) The glue stick of claim 598, wherein the adhesive composition has a viscosity of from 1 Pa·s to 50 Pa·s at 177°C.
- 611. (New) The glue stick of claim 598, wherein the adhesive composition has a softening point of from 70 to 100°C.
- 612. (New) The glue stick of claim 598, wherein the adhesive composition has an application temperature of 190°C or less.
- 613. (New) The glue stick of claim 598, wherein the adhesive composition has a Dot T-Peel of from 3 N to 4,000 N.
- 614. (New) The adhesive of claim 21, wherein the polymer has an amorphous content of at least about 60%.
- 615. (New) The adhesive of claim 21, wherein the polymer has an amorphous content of at least about 70%.
- 616. (New) The adhesive of claim 21, wherein the polymer has an amorphous content of between about 50 and about 99%.
