DETAILED ACTION

1. This is in response to the Applicant's arguments and amendments filed on June 11, 2007 in which claims 52, 57, 59, and 64 have been amended, and claims 43-51, 53-55, and 60-62 have been canceled. Claims 30-42, 52, 56-59, and 63-67 are currently pending.

Allowable Subject Matter

2. After a further search and thorough examination of the present application and in view of the applicant's arguments, and amendments, claims 30-42, 52, 56-57, 66, 67, 59, and 63-65, renumbered as 1-21, are found to be in condition of allowance.

3. The following is an examiner's statement of reasons for allowance: the prior art teaches a tuning circuit determines the broadcast frequency to which the receiver is tuned. The prior art further teaches a wireless adapter for decoding information from a broadcast signal to which a radio is tuned.

On the other hand, the Applicant teaches, inter alia, wherein, upon such activation of said controller, said controller operates a predetermined one of said active frequency detection module or said passive frequency detection module to detect the frequency to which said broadcast receiver is tuned; and, wherein, if no frequency is detected, said controller operates the other of said frequency detection modules to detect the frequency to which said broadcast receiver is tuned. The Applicant further teaches if the received audio signal includes the first audio signal corresponding to the first emitted radio signal, logging the first frequency and a time corresponding to the

emission of the first radio signal at corresponding data locations. These limitations, in conjunction with all limitations of the independent claims, have not been disclosed, taught, or made obvious over the prior art of record.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."


