Continuation of 11. does NOT place the application in condition for allowance because: Applicant's argument summararily pertaining to Shook not meeting the claimed limitation of a "lock position" is acknowledged. Applicant states that Shook doesn't meet the "locked position" limitation because a user must exert physical force onto clutch member 5' for engagement with clutch member 5. However, the argument is not persuasive. Shook is considered to meet the requirement of the claims locked position even in light of applicant's written description in the "Summary of the Invention" on page 2 where stated: "a locked position, wherein the gripping device is coupled to the actuation member by interference of the first engagement surface with the first interference surface".
