REASONS FOR ALLOWANCE

1. The amendment filed 3/12/2009 has been entered. Claims 1-82 are pending.

Allowable Subject Matter

2. Claims 1-82 are allowed.

3. The following is an examiner's statement of reasons for allowance: none the prior art discloses a method comprising: wherein the first training symbol comprises a plurality of data symbols, wherein each of the plurality of data symbols corresponds to different ones of a plurality of tones; and operating a transmitting to transmit the first training symbols on a plurality of antennas, wherein each of the plurality of antennas transmits a corresponding one of the plurality of data symbols; in response to at least the first training symbol, determine a gain at each of the plurality of antennas for each of the plurality of tones.
