

Continuation of 11. does NOT place the application in condition for allowance because: The applicant has provided a Declaration under 37 C.F.R. 131 to overcome the art of record. Initially it is noted that the declaration refers to Appendixes which were not included in the response. Thus Declaration has been considered but is ineffective to overcome the prior art of reference. The evidence submitted is insufficient to establish diligence from a date prior to the date of reduction to practice of the prior art reference to either a constructive reduction to practice or an actual reduction to practice. The applicant argued that the Declaration was not provided earlier since claim 9 was not addressed. The examiner disagrees, claim 9 was rejected along with claim 1, which were both 102 rejections, thus being anticipated. It is also noted that claim 9 was subsequently incorporated into claim 1, wherein the examiner rejected claim 1 by the same grounds. Thus applicant's newly submitted Declaration if showing sufficient evidence for conception and reduction to practice would clearly raise a new issue that was not previously raised, nonetheless the lack of evidence showing either a constructive reduction to practice or actual reduction to practice is noted and thus the Finality of the claims is maintained.
