The following is an examiner's statement of reasons for allowance: None of the prior art teach or suggests a processing method of a semiconductor substrate including processing the semiconductor substrate with irradiating a focused ion beam on a main surface of the semiconductor substrate and forming a salient part which acts as a solid immersion lens and has a curved surface on the main surface, wherein a cutting amount of the semiconductor substrate is adjusted in the processing step by making an irradiation time of the focused ion beam to the semiconductor substrate change corresponding to an irradiation position of the focused ion beam to the semiconductor substrate.
