


Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments: Applicant discussed the differences between the claimed "volumetric data from the image data sets, the volumetric data being indicative of the surface of the person" and the topographical image created in the Sheen reference. Applicant explained that the topographical image is an intensity image and is not equivalent to the "volumetric data". Examiner will further review the claim language and the Sheen reference more carefully to determine if the broad interpretation of "volumetric data" reads on the topographical image created in Sheen.
