

**EXAMINER'S STATEMENT OF REASONS FOR ALLOWANCE**

1. This communication is an Examiner's reasons for allowance in response to application filed on 11/3/03, assigned serial 10/700072, and title "Navigation System with Sign Assistance".

The prior art submitted on 11/3/03, 5/20/04 (identical as 11/3/03), and 5/19/04 have been considered.

2. The following is the Examiner's statement of reasons for the indication of allowable subject matter:

After carefully reviewing the application and the additional search of all the possible areas relevant to the present application, a set of related prior art references has been found, but those prior art references are not deemed strong to make the application unpatentable. Thus, it is found that the application is now in condition for allowance.

Although the references found disclose several claimed limitations, none of the references discloses a navigation system comprising: a database that includes data identifying locations of roadside signs and associated information about roadside signs, wherein associated information includes at least one of: commercial information, historical information and translation of text of the roadside sign into a language other than the language of the roadside signs, and user interface that provides to a user of associated information from database about the at least one roadside sign (claim 21). None of the references found, a mobile computing platform comprising a help button accessible to a user by which the user can request the computing platform to provide information about at least one sign in a vicinity of a current position of the computing platform; and programming that accesses a database that includes information about signs and locations of signs to identify sign in the vicinity of the computing

platform; wherein the information about the sign includes at least one of commercial information, historical information and translation of text of the sign into a language other than the language of the sign (claims 28-29); also, none of the references found, a mobile computing platform comprising a user interface that provides the user with the information about the sign in the vicinity of the computing platform if a specified filter criterion is satisfied, wherein filter criterion relates to commercial information (claim 35).


Claims 21-39, are allowable over the prior art of record.
