Your response of March 21, 2008 was missing the slashes around your name. The slashes which make it a legal signature. See the PDF file attachment with Darryl Forte's note on it.

The Office responded April 3, 2008 and the record does not show you responded to correct this deficiency.

The Notice of Non Compliance the Clerk sent to you indicates your response period can be extended (Rule 136A response to non final).

The Notice was sent out April 3, 2008. The due date was May 3, 2008.

You can extend the response period by paying an extension fee to the Commissioner of Patents same as your prior fee payments.

Your response correcting the missing signature. Your response must be received by August 3, 2008. A three month extension fee of \$525.00 (if received by 8/3/08) must be paid.

Please indicate in your correspondence what the payment is for ( i.e. Three month extension fee in response to correspondence of April 3, 2008).

There is a limit to how long you can extend a response period for before your case is abandoned by law.

Please resubmit your entire response with corrections with the fee to the Office and keep the receipt for your records.
