### DETAILED ACTION

Applicant's amendment filed 7/21/2005 has been entered. Claims 1-8, 10-22, 24-28 are now pending.

#### *Allowable Subject Matter*

Claims 1-8, 10-22, 24-28 are allowed.

The following is an examiner's statement of reasons for allowance:

As discussed in the previous office action, a device for providing thermal compensation for optical elements is commonly known in the art. It is also known in the art to use fiber reinforced laminae for thermally compensating optical elements. The closest relevant prior art is Ogle (US 6,466,716 B1). However, Ogle teaches a fiber reinforced laminae *tube* which encloses a fiber grating structure for providing thermal compensation.

None of the prior art, including the Ogle reference, fairly teaches or suggests, *inter alia*, a fiber reinforced laminae thermal compensating device, wherein the laminae is formed as a composite *plate*, wherein the plate is enclosed in a sealed compartment as a *cantilever free end* as claimed in the instant application.

It is known in the art to provide a sealed compartment and a temperature compensating substrate disposed therein for an optical device (for example, see Hu et al (US 6,356,683 B1) cited in the previous office action), however none of the prior art fairly suggests, *inter alia*, any teachings that would motivate one of ordinary skill in the art to put a cantilever free end fiber reinforced laminae as a thermal compensating device inside a sealed compartment as claimed in the present application.


