

Continuation of 11. does NOT place the application in condition for allowance because: The Beard et al refernece clearly teaches the use of depressurization to remove liquids, note page 2. Thus, the reference is teaching the use of lower pressure to drty the solids. It is noted, that applicants own specification teaches the use of drying apparatus as part of the instant invention. ALso, the claims are open language so that a dryer can be included in the instantly claimed process. THe percent dry is noted, however, it has not been shown that the newly added range is outside the prior art teachings and the prior art does teach drying the solids. THe amount of liquid left would have been within the skill of the art..
