NOTE: The limitations in Claim 1 of a measured ratio value  $H_{ta}/H_{tv}$  and a theoretical ratio value  $Q_b/Q_{uf}$ , and in Claim 8 of the difference between the second measurement value and the second theoretical value being at first and second values which are different than the second predetermined acceptable ratio difference, would require additional consideration and/or search. Whether or not support is available for Claim 8 as amended would also require additional consideration.
