DETAILED ACTION

EXAMINER'S AMENDMENT

1. An examiner's amendment to the record appears below. Should the changes and/or additions be unacceptable to applicant, an amendment may be filed as provided by 37 CFR 1.312. To ensure consideration of such an amendment, it MUST be submitted no later than the payment of the issue fee.

Authorization for this examiner's amendment to claim 18 was given in a telephone interview with David R. Metzger, Reg. No. 32,919 on 19 May 2010.

The application has been amended as follows:

In the Claims:

Claims 8-10 and 23-45 have been cancelled.

In claim 18, line 7, the phrase "forming a reflective layer" has been replaced with "forming a reflective-area layer".

End of examiner's amendment.

Election/Restrictions

2. This application is in condition for allowance except for the presence of claims 8-10 and 23-45 directed to species non-elected without traverse. Accordingly, claims 8-10 and 23-45 have been cancelled. Application/Control Number: 10/714,133 Page 3

Allowable Subject Matter

3. Claims 18-20 are allowed.

4. The following is an examiner's statement of reasons for allowance:

The prior art does not disclose the method of claim 18, in particular the limitations of forming an alignment film which has an alignment direction of 45 degrees with respect to the transmission axis of the polarizer in the reflective area and an alignment direction which is parallel to the transmission axis of the polarizer in the transmissive area, and forming a reflective-area layer which serves as a retardation film on the alignment film, patterning the retardation film such that it remains only in the reflective area. Claim 18 is therefore allowed, as are its dependent claims 19 and 20.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
