Continuation of 3. NOTE:

Applicant's arguments have been fully considered but they are not deemed persuasive. Applicant asserts that either Hellerstein or Drake taught or suggested comparing of the at least one operating parameter with the computer characteristics comprising ranking of host computers suitably to host the software based on a comparison of the at least one operating parameter with a least one of the computer characteristics for each of the host computers.

Examiner respectfully disagrees with the allegation as argued. Examiner in his previous office action, gave detailed explanation of claimed limitations and pointed out an one of an example location in the cited prior art. Here are a few more locations that Applicant is suggested to look at. (See Drake at least the abstract "...generating a ranked list of suitable target systems for a particular product-specific software installation..." see paragraph 0017 "weighted values of various installation parameters related to a target environment are used to programmatically rank candidate systems, prior to building and deployment of an installation package"; see paragraph 0056 "...determining the suitability of various candidate target systems..." also see paragraph 0065 "...analyzes potential target systems using one or more products specific criteria...along with product-specific weights...minimum disk space requirements will be heavily weighted in most cases...")

Examiner is entitled to give claim limitations their broadest reasonable interpretation in light of the specification. See MPEP 2111 [R-1] Interpretation of Claims-Broadest Reasonable Interpretation.
