DETAILED ACTION***Claim Amendment Non-compliant***

The amendment filed 28 November 2006 proposes amendments to the claims that do not comply with 37 CFR 1.173(b), which sets forth the manner of making amendments in reissue applications. A supplemental paper correctly amending the reissue application is required.

Claim Rejections

Claims 1-3 is rejected under 35 U.S.C. 251 as being an improper recapture of broadened claimed subject matter surrendered in the application for the patent upon which the present reissue is based. See *Pannu v. Storz Instruments Inc.*, 258 F.3d 1366, 59 USPQ2d 1597 (Fed. Cir. 2001); *Hester Industries, Inc. v. Stein, Inc.*, 142 F.3d 1472, 46 USPQ2d 1641 (Fed. Cir. 1998); *In re Clement*, 131 F.3d 1464, 45 USPQ2d 1161 (Fed. Cir. 1997); *Ball Corp. v. United States*, 729 F.2d 1429, 1436, 221 USPQ 289, 295 (Fed. Cir. 1984). A broadening aspect is present in the reissue which was not present in the application for patent. The record of the application for the patent shows that the broadening aspect (in the reissue) relates to claim subject matter that applicant previously surrendered during the prosecution of the application. Accordingly, the narrow scope of the claims in the patent was not an error within the meaning of 35 U.S.C. 251, and the broader scope of claim subject matter surrendered in the application for the patent cannot be recaptured by the filing of the present reissue application.

Regarding claim 1, the limitation "using a submersible vehicle (SV) to operate one or more pumps, on a fill and test package to force seawater behind said pig and move said pig from the pig launcher/receiver to the pig receiver", was recited in the original patent but has been removed from the reissue application by the most recent amendment dated 28 November 2006. This limitation is one that Applicant surrendered during prosecution of the original patent application as evidenced by the arguments dated 4 September 2002, pages 2 and 3, in which Applicant cited this limitation as distinguishing the invention over the prior art. For these reasons, removing this limitation is a broadening aspect which constitutes recapture.

Allowable Subject Matter

1. Claims 4-9 are allowed.


