DETAILED ACTION

Claim Objections

1. Claims 6 and 14 are objected to because of the following informalities: 6, line 13, the "linear amplifier" does not produce any output. Similar comment applies to similar limitation, recited in claim 14. Appropriate correction is required.

2. Claims 42-44, 47-49, 51 and 55 are objected to under 37 CFR 1.75 as being a substantial duplicate of claims 2-4, 6-8, 10 and 14, respectively. When two claims in an application are duplicates or else are so close in content that they both cover the same thing, despite a slight difference in wording, it is proper after allowing one claim to object to the other as being a substantial duplicate of the allowed claim. See MPEP § 706.03(k).

Reissue Oath/Declaration

3. In accordance with 37 CFR 1.175(b)(1), a supplemental reissue oath/declaration under 37 CFR 1.175(b)(1) must be received before this reissue application can be allowed.

Claims 2-4, 6-8, 10, 14, 19-20, 24-29, 42-44, 47-49, 51-55, 58, 59, 61-64 are rejected as being based upon a defective reissue Declaration under 35 U.S.C. 251. See 37 CFR 1.175.

Receipt of an appropriate supplemental oath/declaration under 37 CFR 1.175(b)(1) will overcome this rejection under 35 U.S.C. 251. An example of acceptable language to be used in the supplemental oath/declaration is as follows:

"Every error in the patent which was corrected in the present reissue application, and is not covered by a prior oath/declaration submitted in this application, arose without any deceptive intention on the part of the applicant."

See MPEP § 1414.01.

Claim Rejections - 35 USC § 112

4. The following is a quotation of the second paragraph of 35 U.S.C. 112:

The specification shall conclude with one or more claims particularly pointing out and distinctly claiming the subject matter which the applicant regards as his invention.

5. Claims 54 and 59 are rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention.

Claim 54, the limitation "said phase mapper" lacks of proper antecedent basis.

As per claim 59, the limitation "filtering an error signal having one error pulse per unit baud interval" is vague and indefinite as there is an unclear antecedent in claim 61, last paragraph 28. In addition, it is unclear whether the limitation "said filtering step" refers to the "filering" in claim 61, line 4 or claim 61, line 23.

Allowable Subject Matter

6. The indicated allowability of claims 2-4, 6-8, 10, 14, 19-20, 24-29, 42-44, 47-49, 51-55, 58, 59, 61-64 is withdrawn in view of view of the ground of rejection set forth above.
