## DETAILED ACTION

### *Response to Amendment*

1. The objection to the specification has been withdrawn in light of applicants' amendments to the specification and submissions of the material data safety sheets for the trademarked items.

The rejections under 35 U.S.C. § 112, second paragraph, have been withdrawn in light of applicants' amendments to the specification and submissions of the material data safety sheets.

The previous rejections under Pearson et al. have been withdrawn in light of applicants' amendments and arguments.

### *Claim Rejections - 35 USC § 102*

2. The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

3. Claims **1-7, 55-62 and 110-116** are rejected under 35 U.S.C. 102(b) as being anticipated by Steinbeck (US Pub 2002/0164651). Steinbeck teaches a method of identifying a contaminant on a substrate by irradiating the sample, obtaining a spectrometry reading [0037] and determining two absorbance peaks at two wavenumbers and identifying a contaminant by correlating the two absorbance peaks to

the known absorbance peaks of a contaminant at the first and second wavenumbers ([0122]).

***Claim Rejections - 35 USC § 103***

4. The following is a quotation of 35 U.S.C. 103(a) which forms the basis for all obviousness rejections set forth in this Office action:

(a) A patent may not be obtained though the invention is not identically disclosed or described as set forth in section 102 of this title, if the differences between the subject matter sought to be patented and the prior art are such that the subject matter as a whole would have been obvious at the time the invention was made to a person having ordinary skill in the art to which said subject matter pertains. Patentability shall not be negated by the manner in which the invention was made.

5. The factual inquiries set forth in *Graham v. John Deere Co.*, 383 U.S. 1, 148 USPQ 459 (1966), that are applied for establishing a background for determining obviousness under 35 U.S.C. 103(a) are summarized as follows:

1. Determining the scope and contents of the prior art.
2. Ascertaining the differences between the prior art and the claims at issue.
3. Resolving the level of ordinary skill in the pertinent art.
4. Considering objective evidence present in the application indicating obviousness or nonobviousness.

6. This application currently names joint inventors. In considering patentability of the claims under 35 U.S.C. 103(a), the examiner presumes that the subject matter of the various claims was commonly owned at the time any inventions covered therein were made absent any evidence to the contrary. Applicant is advised of the obligation under 37 CFR 1.56 to point out the inventor and invention dates of each claim that was not commonly owned at the time a later invention was made in order for the examiner to consider the applicability of 35 U.S.C. 103(c) and potential 35 U.S.C. 102(e), (f) or (g) prior art under 35 U.S.C. 103(a).

7. Claims **8-54, 63-109 and 117-163** are rejected under 35 U.S.C. 103(a) as being unpatentable over Steinbeck (US Pub 2002/0164651). Steinbeck teaches a method of identifying a contaminant by comparing two absorbance peaks to known absorbance values ([0122]). It is obvious to one of ordinary skill in the art to optimize within prior art conditions through routine experimentation. *In re Boesch*, 617 F.2d 272, 205 USPQ 215 (CCPA 1980) teaches that optimization of a result-effective variable is ordinarily within the skill of one in the art. A result-effective variable is one that has well-known and expected results.

The selection of a sample containing more than one component is a result effective variable. Analyzing a sample containing more than one component has the well-known and expected result of producing a different absorbance peak for each component of the sample. Extrapolating on the analysis used by Steinbeck, one of ordinary skill in the art would have the tools to determine the identity of any contaminant by first obtaining the at least two absorbance peaks of a known contaminant for future comparison with contaminant samples of unknown origin.

### ***Double Patenting***

8. The nonstatutory double patenting rejection is based on a judicially created doctrine grounded in public policy (a policy reflected in the statute) so as to prevent the unjustified or improper timewise extension of the “right to exclude” granted by a patent and to prevent possible harassment by multiple assignees. A nonstatutory obviousness-type double patenting rejection is appropriate where the conflicting claims are not identical, but at least one examined application claim is not patentably distinct from the reference claim(s) because the examined application claim is either anticipated by, or would have been obvious over, the reference claim(s). See, e.g., *In re Berg*, 140 F.3d 1428, 46 USPQ2d 1226 (Fed. Cir. 1998); *In re Goodman*, 11 F.3d 1046, 29 USPQ2d 2010 (Fed. Cir. 1993); *In re Longi*, 759 F.2d 887, 225 USPQ 645 (Fed. Cir.

1985); *In re Van Ornum*, 686 F.2d 937, 214 USPQ 761 (CCPA 1982); *In re Vogel*, 422 F.2d 438, 164 USPQ 619 (CCPA 1970); and *In re Thorington*, 418 F.2d 528, 163 USPQ 644 (CCPA 1969).

A timely filed terminal disclaimer in compliance with 37 CFR 1.321(c) or 1.321(d) may be used to overcome an actual or provisional rejection based on a nonstatutory double patenting ground provided the conflicting application or patent either is shown to be commonly owned with this application, or claims an invention made as a result of activities undertaken within the scope of a joint research agreement.

Effective January 1, 1994, a registered attorney or agent of record may sign a terminal disclaimer. A terminal disclaimer signed by the assignee must fully comply with 37 CFR 3.73(b).

9. Claims **1-163** are rejected on the ground of nonstatutory obviousness-type double patenting as being unpatentable over claims 1-33 of U.S. Patent No. 6,906,327. Although the conflicting claims are not identical, they are not patentably distinct from each other because it is inherent that one must first identify a contaminant in order to determine the amount of a contaminant in a sample. Thus, it would have been obvious for one of ordinary skill in the art determining the amount of a contaminant on a substrate to first determine the identity of the contaminant by correlating the at least two absorbance peaks.

#### ***Response to Arguments***

10. Applicant's arguments, see Amendment after Non-Final, filed March 4, 2008, with respect to the rejection(s) of claim(s) 1-163 under *Pearson et al.* have been fully considered and are persuasive. Therefore, the rejection has been withdrawn.

However, upon further consideration, a new ground(s) of rejection is made in view of *Steinbeck* (US Pub 2002/0164651 A1).
