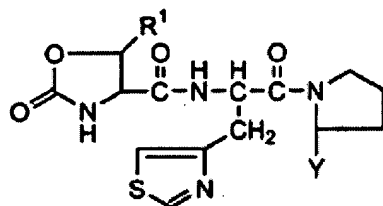

The 112 rejection made in the previous office have been overcome by the Amendment filed on 28 September 2006.

Reasons For Allowance

The following is an examiner's statement of reasons for allowance:

The invention relates to a method of preparing stereochemically-controlled synthesis of



compounds of Formula

. The method comprises of several

steps that includes the disteroconversion of chiral 2-amino alcohols via oxazolidinones. The closest prior art of record is to US Patent No. 6,319,902 B1. The method described in this application differs from the prior art in that the process of this application involves two additional hydrolysis steps and a peptide bond formation that result in the formation of the desired product. The prior art neither teach nor suggest the different steps of the processes described in this application.
